## Reporting Period Ending June 30, 2021 – Final Report

As part of the Coronavirus Response and Relief Supplemental Appropriations Act (CRRSAA), signed into Law by President Trump on December 27, 2020, the Department of Education has made available funding to provide relief to students whose enrollment was disrupted by the COVID-19 outbreak. Davis Technical College has been allocated funding from the CRRSA Act and must utilize at least \$356,638 of the funds as Emergency Financial Aid Grants to eligible students, which is equal to the amount required under the CARES Act. To comply with requirements to receive the funding and distribute to students, Davis Technical College must provide the following information:

1. An acknowledgement that Davis Technical College signed and returned to the Department the Certification and Agreement and the assurance that Davis Technical College has used, or intends to use, no less than \$356,638, or the same amount of the funds received under Section 18004(a)(1) of the CARES Act to provide Emergency Financial Aid Grants to students.

As part of the agreement and certification that was signed by Davis Technical College on April 14, 2020, it is our intention to use at a minimum \$356,638, or the same amount of funds received under the CARES Act, as direct payments to students that had their enrollment disrupted as a result of the COVID-19 outbreak. Our application was submitted to the Department of Education using the Grants.Gov system on April 15, 2020.

2. The total amount of funds that Davis Technical College will receive or has received from the Department pursuant to the institution's Certification and Agreement [for] Emergency Financial Aid Grants to Students.

Davis Technical College has received **\$356,638** from the Department of Education to use as Emergency Financial Aid Grants as payments to be made directly to students.

3. The total amount of Emergency Financial Aid Grants distributed to students under the CRRSA Act as of the date of submission.

For the reporting period of April 1, 2021 – June 30, 2021, Davis Technical College disbursed \$369,035 to 573 students.

This represents the entire allocation of CRRSA Act funds that was set aside as direct payments to students, plus an additional \$12,397 was used from the institutional portion as grants to students.

4. The estimated total number of students at Davis Technical College that are eligible to receive Emergency Financial Aid Grants under CRRSA Act.

Davis Technical College has approximately 750 students that were potentially eligible to receive the CRRSA Act Emergency Financial Aid Grants. This is the number of students that have completed the 2019-2020 or 2020-2021 or 2021-2022 FAFSA and enrolled in a certificate seeking program at the time that payments were made. Davis Tech policy required that students either be actively

enrolled and attending at the time of the grant payment or had graduated from their program since December 27, 2020. A student who had withdrawn from their program or were without an active schedule were not eligible to receive the grant payment.

At the time of awarding, the CRRSA Act Emergency Financial Aid Grant required students to be either a US Citizen or Eligible Non-Citizen. The FAFSA was used to confirm a student's eligibility.

5. The total number of students who have received an Emergency Financial Aid Grant to students under the CRRSA Act.

As of June 30, 2021, Davis Technical College has disbursed funds to 573 students.

6. The method(s) used by Davis Technical College to determine which students receive Emergency Financial Aid Grants and how much they would receive under the CRRSA Act.

Davis Technical College used the FAFSA to determine a student's eligibility to receive the CRRSA Act Emergency Financial Aid Grant and no other application process was used to distribute the grants to students.

A student could have completed either the 2019-2020 or 2020-2021 or 2021-2022 FAFSA. If a student completed more than 1 FAFSA the most recent FAFSA was used. Since the grants are supposed to go to students with the financial need, the EFC was used from the FAFSA to determine the Emergency Financial Aid Grant payment amount:

7. Any instructions, directions, or guidance provided by the institution to students concerning the Emergency Financial Aid Grants.

Once the eligible students were identified, an email was sent to notify the students of the CRRSA Act Emergency Financial Aid Grant and encouraged to complete the direct deposit form, however it was not required. If a student did not complete the direct deposit form a check was mailed to their mailing address on their student record. Nothing else was required of the student to receive the Emergency Financial Aid Grant.
