A motion was made by Scot Merrihew to approve the Career Path High FY 2023-2024 School Trust Lands plan, seconded by Brandon Howard. Motion passed.

Training Division Approvals

New Program and Differential Tuition

Vice President Mock shared information on the proposed new program Commercial Driver License – Class A (CIP code: 49.0205). The tuition rate will be \$295.00 per credit hour (which is a differential tuition rate due to the cost of the program) for a total of \$1,770 for the full program. It is six credit hours or 180 clock hours. Funding to assist with the cost of starting the program is being sought from a Talent Ready grant.

FY 2024 Program Changes

Davis Technical College has a few program changes for FY 2024. The changes are as follows:

- Advanced Emergency Medical Technician will change from 150 clock or five credit hours to 186 clock or six credit hours.
- Emergency Medical Technician will change from 150 clock or five credit hours to 186 clock or six credit hours.
- Nursing Assistant will change from 115 clock or three credit hours to 114 clock or three credit hours.
- Welding Technology will change from 900 clock or 30 credit hours to 720 clock or 25 credit hours.
- Dental Assisting will change from 900 clock with 30 credit hours to 29 credit hours.
- Pharmacy Technician's name is being changed to Pharmacy Technician Advanced.
 Clock hours will change from 710 to 600 hours or 17 credit hours.
- The name of Electrical Apprentice is being changed to Electrical Apprenticeship.
- The name of Plumbing Apprentice is being changed to Plumbing Apprenticeship.
- Construction Management is proposed to be taught out.

A motion to approve the new program and differential tuition, and FY 2024 program changes was made by Tucker Morgan, seconded by Tami Tran. Motion passed.

President's Report

Davis Technical College hosted KSLTV's Casey Scott as he and his crew interviewed the students, faculty, and staff, and promoted the Open House held on March 14.

President Brush provided an institutional performance report. The report included information on the 2023 General Session, FY 2024 appropriations and the goals and opportunities for the College.
